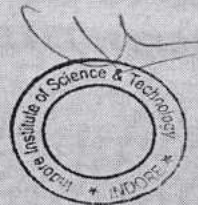
- x) Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.
